#### **Overview**

RAILTRAC® Version 17.3.2 introduces key fixes, enhancements, and new features to improve performance, usability, and functionality across various modules. This release is optimized for 1280x1024 resolution and fully compatible with RAILTRAC® Advance™.

#### **Car Management**

- New: Comment Type/Code now available when adding a new Hot List
- Fixed: Hot List comments now correctly display the flame icon on all cars, regardless of trip status
- Fixed: Resolved errors when updating the acknowledgment flag on single or multiple cars within the Hot List

#### **Car Location Messages (CLMs)**

- Fixed: Behavior corrected when Sight Code is 'Q' and trips are deleted
- Fixed: Sorting issues resolved on the Current CLMs screen

#### **Cosmetic Enhancements**

- Added: New 'Freight Payment Code' options on the Shipment Detail screen
- Updated: Corrected grammatical issues in shipment field labels
- Error message clarified when adding trip comments that exceed character limits

#### **Detention Management**

- Fixed:
  - Proofing & Editing report updates correctly after manual trip modifications
  - Days Held and Days Charged calculations improved
  - Issue resolved with incorrect changes to Detention flags on Shipment Detail screen
  - Total Detention Amount values now display accurately
  - Proofing & Editing screen updated for tiered detention limits
  - Invoice and Summary report now reflect accurate totals and averages
  - Default sort setup locked to improve report queries
  - Date/Time tooltips added to detention report fields
  - Det Override and Det Recalc operations fixed on the Proofing & Editing screen
  - All records can now be selected from the row counter
  - Tiered detention records correctly display only relevant rate tiers
  - Product field now displays the Commodity Short Name

- Filters added to Printing & Posting and Invoice Review screens on available columns
- Print/Extract Invoice function now works in Printing & Posting
- New Feature:
  - Introduced a Detention Adjustment operator to modify detention amounts on the Proofing & Editing screen. Adjustments are reflected in:
    - Proofing & Editing
    - Printing & Posting (Print/Extract Invoice)
    - Invoice Review (Reprint Invoice)
    - Summary Analysis

## **GPS**

- Increased Alert Type column size on GPS reports and added tooltips for extended alert descriptions

## **Interface Validations**

- Fixed:
  - Error when updating Ship Date through Interface Validations
  - Issue when adding or batching cars to import

## **Lease/Rider Management**

- Issue when adding a Rider with a \$0.00 Monthly Rental Amount
- Error when deleting Riders from the Lease Parties screen

## **Parties Management**

- Fixed:
  - Issue with navigation on Detention Seasonal Profile screen
  - Issue when modifying and saving a Detention Profile
- Added: Tiered Detention Details to Customer data windows
- Modified: Detention Profile Maintenance screen to prevent invalid configurations

## **Performance & General Functionality**

- Improved performance on Edit Shipments screen
- Addressed inconsistencies between Path Code and Truck Delivery
- Resolved error when adding Hot List comments
- Increased maximum value for detention amount fields

## **Reports**

- Fixed:
  - Default sort window on Shipments by Car Profile report
  - Filter issue on Commodity Shipped screen
  - Open Shipments filter on Ship Date
  - Error on Fleet Sizing Detail reports resolved

## **Routes**

- Fixed ETA calculation errors
- Updated the auto-generate route process to populate the Non-Line Haul Origin and Delivery Carriers on the Route Segments table and screen

**Trace Shipments**

- Improved query logic on Car Locations by CLMs report

**Trip Management**

- Fixed:
  - Error when adding Consign Dlv Hours to Destination Criteria
  - Issue when adding Load & Hold trips for non-existent cars
  - Product data now added correctly to trips

**User-Defined Fields**

- Added: Display of Redefinable Date field labels on Car Profile screens
